APPLICATION PROCESS



1. Call the Trustee's office to schedule an appointment.

2. After being assigned a caseworker,fill out an application online or at the office Monday-Friday from 8:30am-3:00pm.

3.Bring in or e-mail all required documents to your caseworker.

4.Allow 72 business hours for the Township to investigate your case and decide eligibility based upon Township guidelines.

Duties of the Trustee

Fire Protection- Indiana law charges for protection to the township trustee with the responsibility of providing ambulance service for the areas of the township not incorporated into a city or town.

Poor Relief- overseeing and distributing poor relief is a primary duty in many townships. The Trustee provides emergency service to those who meet the guidelines established by the Indiana Code.

Burial- Burial assistance is available from the Township Trustee when no other means are available.

Financial- Each August, the Trustee prepares and submits a budget for the year to the five Township board members for approval. As the Chief Financial Officer of the Township, the Trustee pays and records all claims for the Township expenses and salaries and is responsible to keep accurate records and follow all financial guidelines set in the Indiana Code.

Additional Services for Pike Township Residents

Emergency Assistance- Eligible applicants may be granted vouchers to help with food, rent, utilities, or burial expenses in emergency situations

Commodities/Food-The Trustee's office has a onsite emergency pantry for those facing food insecurity. The office will also provide referrals to other agencies in the area.

Emergency Shelter-The Trustee can provide emergency shelter referrals.

Cemeteries-The Trustee provides care for abandoned cemeteries.

Mother/Baby Room-The Trustee assists mothers in need of baby items.
